That has enabled the RAPS Committee to take a closer look at its communication channels with the membership, starting with the website. As things stood, a newcomer to RAPS could be forgiven for wondering what RAPS was all about without further digging. A strap-line displayed prominently might help, so we added **Ensuring your voice is heard** plus some small print: *RAPS is an independent, non-political association representing the interests of the whole Port Solent community, helping to sustain Port Solent as a pleasant, safe and unique place to live, work and enjoy.*

There was talk at the 2023 AGM of providing an interactive discussion space on the RAPS website. The Committee gave it some thought and concluded that this was better left to social media groups with a Port Solent focus, such as Stuart Taylor's *Voice for Port Solent* on Facebook. Stuart takes up the story:

"When I moved to Port Solent in August 2023 I was made aware of an old Facebook group that had once been very active for Port Solent residents but had been archived earlier in the year as the admins were no longer able to run it. I was able to contact them and have the group re-enabled as *Voice for Port Solent*. Since then the discussions have been varied, with people looking for help and with businesses advertising themselves in the area - mind you, we keep coming back to questions about the heating systems! Early in 2024 we started to suffer from spam and resolved this by making the group private, which meant that we can spot and reject spammers when they try to join. The group continues to grow by around 5% each month and we are now at 1024 members, many of whom post regularly about events or activities that might be of interest to members. We have found it a great source of information since moving here and gained plenty of advice and knowledge about the houses and about the area. We hope this will continue."`
